

This year's Board met for the first time at the initial meeting of the annual planning session on July 10. A second planning session will be held September 26. It will be at this meeting that we will finalize our plans and goals for the year

August 8. SUPPORT BALLOT MEASURES 15 & 16

During the last regular legislative session, two bills regarding seismic event preparation passed the legislature. Because the bills involve a change in the Oregon constitution, the legislation was referred by the legislature to the November ballot.

Ballot measures 15 and 16 authorize the State to issue general obligation bonds to fund seismic rehabilitation of public education buildings (Measure 15) and emergency services buildings (Measure 16).

ACEC Oregon has furnished a statement of support for both ballot measures, look for them in your November voter guide. In addition, ACEC Oregon has joined a coalition called "Oregonians for Safer Buildings" that supports the passage of ballot measures 15 and 16.

FIRST SCHOLARSHIP RECIPIENT NAMED; WILL ATTEND PORTLAND STATE IN FALL

ACEC Oregon is proud to announce the first recipient of the ACEC Oregon Scholarship – Rex Whistler from Gresham High School.

Rex is starting the mechanical engineering program at Portland State University this fall, and his particular areas of interest include energy conservation and renewable energy fields. While Rex had strong test scores and GPA, his senior project was what caught the attention of the Scholarship Committee – converting a 1969 VW bug to electric power.

The Scholarship Committee was not only impressed with Rex's strong interest in science and engineering but also his wide variety of other

As Rex was awarded another scholarship to cover his tuition, this first ACEC Oregon scholarship will provide \$2,500 annually for four years to cover fees and books.

Future ACEC Oregon scholarships will cover tuition and fees for four years at an Oregon college that has an ABET-accredited engineering program. Qualifying Oregon schools are: Oregon State University, Portland State University, University of Portland and the Oregon Institute of Technology.

ACEC Oregon is working to build an endowment fund for the scholarship program and has established an account with the Oregon Student Assistance Commission so that donations are tax-deductible.
